AGREEMENT: Lisa Carolyn Morrison of 248 Yan Yean Rd, Plenty in the State of Victoria for and on behalf of the Morrison Family ("The Morrisons") which owns and operates the animal boarding facility ("the facility")

and.....

...who are lodging their animal/s in the care custody of the Morrisons ("the client")

1. The Morrisons conduct the business of a boarding kennel and cattery at 248 Yan Yean Rd., Plenty in the State of Victoria providing for the care of animals on a fee for service basis is provided together with veterinary; and additional care as required during any particular boarding period as requested by the client and provided by the Morrisons.
2. The client wishes to utilize the facility and services provided by the Morrisons for the periodand from time to time thereafter to be notified to the Morrisons who may or may not accept the opportunity to provide additional service and facilities.
1. Unless otherwise notified by the owners, it is agreed between the parties that the terms and conditions which will apply as between them for the boarding of animals at the facility will be as set in this Agreement whether for the first period of the provision of services or any later period or periods.

CONDITIONS OF BOARDING:

1. The name of the pet(s).....
2. We give permission for our dog to be paired with one other dog.....
3. The coat condition of the pet on arrival.....
4. Person nominated to collect the pet/s if client is not doing so.....
5. The Morrisons reserve the right to refuse entry to the facility of any animal.
6. Full period booked by the client will be charged.
7. The client agrees to pay all additional costs and charges for special services whether requested or in the judgment of the Morrisons they are needed, including all veterinary costs.
8. The client specifically represents that he or she is the sole owner of the pet/s free and clear of all liens and encumbrances.
9. All charges incurred by the client must be paid before the pet leaves the facility.
10. We will take every precaution to ensure your pet has a happy and safe stay, but Cottage Kennels will not accept responsibility for Canine Influenza, loss or any kind of death.
11. In the event that it is necessary for the proprietors or staff of the facility to seek veterinary assistance without the consent of the client who may be unavailable to provide such consent, then the client agrees that the cost of any procedure undertaken as a result will be their responsibility.
12. If a pet/s is not collected within (7) days of expiry of the boarding period, Cottage Kennels and Cattery reserves the right to dispose of the pet according to the provisions of part (5) of the Domestic (Feral and Nuisance) Animal Act.
13. By signing these conditions the client certifies to the accuracy of all information given about the pet/s. The client acknowledges that the signing of this contract will create a lien over the animal/s in favor of Morrisons which lien will continue to exist whilst ever monies are owing to them..
